"The Path That Ends AIDS" Report

Context: Recently, UNAIDS made a significant announcement stating that despite the numerous challenges, there is a feasible path to end AIDS.

Report Findings:

AIDS Impact: In 2022, AIDS claimed a life every minute, with approximately 9.2 million people unable to access HIV treatment worldwide.

Treatment Status: Around 29.8 million people are receiving HIV treatment, and a target of 35 million people receiving treatment by 2025 seems achievable with sustained success.

Gender Disparities: Men living with HIV had lower treatment rates compared to women.

Children Affected: Despite a 64% reduction in AIDS-related deaths among children since 2010, around 84,000 children lost their lives to HIV in 2022.

Report Suggestions:

Stigma-Free Healthcare: Eliminating stigma in healthcare facilities and removing distrustful laws and practices are crucial.

Female-Friendly Prevention: Easier access to female-friendly biomedical prevention tools can reduce HIV risks in sexually active girls and women.

Funding and Prevention: Closing gaps in funding, particularly in prevention, can lead to further declines in HIV incidence.

About UNAIDS:

Joint Programme: UNAIDS leads global efforts to end AIDS by 2030 as part of the Sustainable Development Goals, coordinating 11 United Nations system Cosponsors.

Mission: UNAIDS aims to achieve universal access to HIV prevention, treatment, care, and support.

Civil Society Representation: UNAIDS is a model for United Nations reform and has civil society represented on its governing body.

HIV and AIDS Overview:

What is HIV?

HIV (human immunodeficiency virus) weakens the body's immune system, making it vulnerable to infections and diseases.

What is AIDS?

AIDS is the late stage of HIV infection when the immune system is severely damaged.

Treatment: There is no cure for HIV, but effective antiretroviral therapy (ART) helps reduce viral load and prevents AIDS progression.

Efforts in India: National AIDS Control Organization (NACO) leads HIV/AIDS control programs in India, aiming to end AIDS by 2030.

National AIDS Committee: Constituted in 1986 in the Ministry of Health and Family Welfare after the first AIDS case was detected.

National AIDS Control Programme: Launched in 1992, NACO was formed to implement the program.

95-95-95 Strategy: Aims for 95% testing, treatment, and viral suppression rates by 2025, succeeding the earlier 90-90-90 Strategy.

India-UAE Relations

HYEYA Most trusted since 200

Context: Recently, the Prime Minister of India undertook his fifth visit to the United Arab Emirates (UAE) within the past eight years.

Outcomes of the Visit:

MoUs Signed: Various MoUs signed for promoting use of local currencies (INR-AED) for cross-border transactions, interlinking payment and messaging systems, and establishing Indian Institute of Technology – Delhi in Abu Dhabi.

Energy Sector: Cooperation in Green Hydrogen, solar energy, and grid connectivity; increased investment in India's Strategic Petroleum Reserve Programme.

Climate Change: Joint work on climate change issues during India's G20 and UAE's COP28 presidency; commitment to make COP28 a success.

Indian Diaspora: UAE's appreciation for the Indian diaspora's significant role in the country, reinforcing bilateral relations.

Bilateral Trade: Economic partnership stands at USD 85 billion, aiming to achieve USD 100 billion target before G20 meeting in Delhi.

Local Currencies for Cross-Border Transactions:

Pact: India and UAE signed an agreement to establish a framework for promoting rupee and UAE Dirham (AED) use in cross-border transactions.

Mechanism: Local Currency Settlement System (LCSS) to enable invoicing and payment in domestic currencies, developing an INR-AED foreign exchange market.

Significance: Facilitating investments, remittances, and reducing transaction costs and time for remittances from Indians in UAE.

Crude Oil Payments: India may use the mechanism for crude oil and other imports from UAE, currently made in US dollars.

Brief on India-UAE Bilateral Relations:

Diplomatic Relations: Established in 1972.

Shared Visions: India's Vision 2047 and UAE's Centennial Plan create commonalities in long-term vision, strengthening economic ties.

Comprehensive Economic Partnership Agreement (CEPA): Boosted bilateral trade, making UAE India's third-largest trading partner.

NRI Remittances: Large Indian community in UAE contributes over US\$17.06 billion in remittances annually.

Energy Security: UAE's reliability as an energy exporter complements India's industrial and manufacturing growth.

Technology Partnerships: Signed digital innovation, technology partnerships, and collaborations on space missions.

Strategic Convergences: Shared views on strategic issues like US dollar dominance, terrorism, and rules-based international order.

Minilateral Groupings: Formed India-Israel-US-UAE (I2U2) and India-UAE-France maritime trilateral.

Standing Committee on Statistics (SCoS)

Context: Recently, the government established a new panel to review all data from the National Statistical Office (NSO).

About SCoS:

Mandate Expansion: The Standing Committee on Economic Statistics (SCES) replaced by Standing Committee on Statistics (SCoS) with a broader mandate to review all surveys under the National Statistical Office (NSO).

Chairman & Members:

Chairman: Pronab Sen, India's first chief statistician and former chairman of the National Statistical Commission (NSC), appointed as chair of SCoS.

Membership: SCoS comprises 10 official members and four non-official members, including eminent academics, with provision for up to 16 members as per MoSPI order.

Significance:

Addressing Critiques: Formation of SCoS holds significance amid critiques of India's statistical machinery by members of the Economic Advisory Council to the Prime Minister.

Terms of Reference: SCoS tasked with reviewing all survey frameworks, methodology, and results, identifying data gaps for official statistics, and strategizing to fill those gaps.

Use of Administrative Statistics: Mandated to explore using administrative statistics to improve data outcomes. **Survey Results Approval:** While the panel finalizes survey results, the NSC retains ultimate authority to approve publication.

Ministry of Statistics and Programme Implementation (MoSPI):

Creation: Formed as an independent ministry in 1999 through the merger of the Department of Statistics and Department of Programme Implementation.

Wings: Comprises Statistics Wing (National Statistical Office - NSO) and Programme Implementation Wing.

Statistics Wing: Includes Central Statistical Office (CSO), Computer center, and National Sample Survey Office (NSSO).

Programme Implementation Wing: Divided into Twenty Point Programme, Infrastructure Monitoring, and Project Monitoring, and Member of Parliament Local Area Development Scheme.

National Statistical Commission: An autonomous body established by a government resolution, responsible for the development and approval of statistical methodologies and standards.

Indian Statistical Institute: An autonomous institute of national importance dedicated to research and teaching in statistics, declared so by an Act of Parliament.

	Decline in Poverty: According to the "National MPI, A Progress Review, 2023" by NITI Aayog, India has experienced a significant decline of 9.89 percentage points in multidimensional poverty. It decreased from 24.85% in 2015-16 to 14.96% in 2019-2021.	
	Dimensions Considered: The index evaluates three fundamental dimensions: health, education and standard of living. It analyzes indicators like nutrition, child mortality, years of schooling, access to electricity, sanitation and housing quality.	
	Regional Disparities: The MPI helps identify regional disparities in poverty, enabling targeted policy interventions to uplift the most vulnerable communities.
