<ul> <li>About the New Mechanism</li> <li>The proposal envisages centralised scheduling for dispatching the entire annual electricity consumption of around 1,400 billion units, both inter-state and intra-state.</li> <li>According to the Centre, the current model will deepen power markets in line with the Centre's 'One Nation, One Grid, One</li> </ul>	<ul> <li>Electricity Market</li> <li>Power is in the Concurrent List of the Constitution.</li> <li>Currently, the Indian electricity market is a decentralised, voluntary pool-based and diversified ranging from long-term power purchase agreements (PPAs), cross border PPAs, short and medium term bilaterals, day-ahead power exchange, and a real-time online market.</li> <li>Over 87% of the installed power capacity is tied up under long</li> </ul>
<ul> <li>Frequency, One Price' formula.</li> <li>The mandatory pool based model will ensure that the cheapest electricity generating resources across the country are supplied to meet the overall system demand.</li> <li>As part of this, an algorithm called the Security Constrained Economic Dispatch (SCED) has been developed by the National Load Dispatch Centre.</li> <li>It is aimed at assisting regulators in making informed calls on scheduling decisions on a nationwide basis.</li> <li>It will result in at least 5% savings for customers.</li> <li>NLDC was established by the Ministry of Power in 2005 in terms of provisions under Electricity Act 2003.</li> </ul>	<ul> <li>term PPAs of around 25 years. The remaining 13 % is transacted in the power exchanges and through short-term and medium-term bilateral deals.</li> <li>Current Management of Electricity Grid</li> <li>The electricity grid is divided into state-wise autonomous control areas managed by the State Load Dispatch Centres (SLDCs), which in turn are supervised by Regional Load Dispatch Centres (RLDCs) and the National Load Dispatch Centre (NLDC).</li> <li>Each control area is responsible in real time for balancing its demand with generation resources.</li> <li>At present, each control area or state follows merit-order dispatch (cheapest power dispatched first) from the basket of intra-state and inter-state resources and buys or sells on the day-ahead power exchange.</li> <li>The un-tied generators in the private sector sell electricity, on a voluntary basis, in the bilateral market as well as on the power exchanges.</li> </ul>

- When hurricane
  - reaches land, it pushes a wall of water ocean
  - ashore. This wall of water is called
  - a storm surge.
- There are five types, or categories, of hurricanes. The scale of categories is called the Saffir-Simpson Hurricane Scale. The categories are based on wind speed.

- A hurricane starts out as a tropical disturbance. This is an area over warm ocean waters where rain clouds are building.
- A tropical disturbance sometimes grows into a tropical depression. This is an area of rotating thunderstorms with winds of 62 km/hr or less.
- A tropical depression becomes a tropical storm if its winds reach 63 km/hr.
- A tropical storm becomes a hurricane if its winds reach 119 km/hr.

#### Context

#### \* Key Highlights

• Ponniyan Selvan means the son of Ponni (the Cauvery River).

- The novel was penned by author and freedom fighter Kalki Krishnamurthy, and serialized from 1950-54 on a weekly basis in Tamil magazine 'Kalki'.
- It tells the story of early days of Rajaraja I, born Arunmozhi
   Varman and considered the greatest of all Chola rulers.
- In world history, the Cholas are among the longest recorded dynasties with their reign peaking in the ninth and tenth centuries.
- During this period, the entire area south of the Tungabhadra River was brought together as a single unit under the Cholas.

## China Blocks Listing of Lashkar 'Commander'

#### Context

For the third time in three months, China blocked a joint India-U.S. attempt to put a Pakistan-based terrorist on the UN Security Council's (UNSC) 1267 list.

#### \* Key Highlights

 It will Place a hold on the proposal to add Lashkar-e-Taiba 'commander' Sajid Mir, who is wanted for the 26/11 Mumbai terror attacks, as well as attacks in the U.S. and Denmark.

#### ✤ UNSC 1267 committee

- It is one of the most important and active UN subsidiary bodies working on efforts to combat terrorism, particularly in relation to Al Qaeda and the Islamic State group.
- It comprises all permanent and non-permanent members of the UNSC

## **Reducing Anonymous Political Donations**

#### ✤ <u>Context</u>

The Election Commission has proposed reducing anonymous political donations to ₹2,000 from ₹20,000 and cap cash donations at 20% or at a maximum of ₹20 crore to cleanse election funding of black money.

#### \* Key Highlights

The proposals are aimed at ushering in reforms and transparency in donations received by political parties, and also the expenditure incurred by candidates.
As per rules in force currently, political parties have to disclose all donations above ₹20,000 through their contribution report that is submitted to the EC.
If the EC's proposal is approved by the Law Ministry, all donations above ₹2,000 shall be reported, thereby enhancing transparency in funding.

#### Other Recommendations

The EC has sought to make digital transactions or account payee cheque transfers mandatory for all expenses above ₹2,000 to a single entity/person.
As of now, maintaining a separate bank account for poll expenditure is part of instructions but EC wants it to become part of Conduct of Election Rules.
The EC also wants every candidate to open a separate bank account for election purposes, route all expenses and receipts through this account, and furnish these details in their account of election expenditure.

#### Key Highlights \*



- The Asiatic caracal (Caracal caracal schmitzi) is an elusive medium-sized and locally threatened felid (cat) species, which has been widely reported to be on the brink of extinction in India.
- The reasons are large-scale hunting, illegal trading and loss of natural habitats are considered significant threats to the species.



- The caracal is currently included in Schedule I of the Wild Life (Protection) Act, 1972 and the Near Threatened category by the Conservation Assessment and Management Plan and International Union for Conservation of Nature Red list assessment in India.
- The researchers found the most significant potential habitat for caracals in Rajasthan, with an area of 25,221.38 square kilometres, followed by Gujarat (16,652.1 sq km), Madhya Pradesh (6416.01 sq km), Haryana (191.36 sq km), Uttar Pradesh (131.11 sq km), and **Maharashtra** (34.17 sq km).



- **Note:** The caracal was the only other feline which was used for hunting in India. Firoz Shah Tughlaq had many of them in his hunting establishment.
- They also noted that large amounts of caracal suitable habitats in India fell within protected areas, thus providing an excellent opportunity for its conservation in the already existing management & conservation setup.




## **PM-PRANAM**

Genus - Caracal

- Context
  - The Union government intends to launch a scheme named PM PRANAM (PM Promotion of Alternate Nutrients for Agriculture Management Yojana).

#### Key Highlights \*\*

- Union Ministry The of Chemicals and **Fertilisers** has initiated inter-ministerial discussions and consultations with states.
- **Objectives**:
  - To reduce the use of chemical fertilisers by incentivising states.
  - To bring down the subsidy burden on chemical fertilisers.
- The subsidy burden is estimated to reach Rs 2.25 lakh crore in 2022-23 - 39% higher than last year's figure of Rs 1.62 lakh crore.



#### ✤ Implementation

- The scheme will have no separate budget and will be financed through the "savings of existing fertiliser subsidy" under schemes run by the Department of Fertilisers.
- 50% of subsidy savings will be passed on as a grant to the state that saves the money.
- 70% of the grant provided under the scheme can be used for asset creation related to technological adoption of alternate fertilisers. The remaining 30 % grant money can used for rewarding and encouraging farmers, be panchayats, farmer producer organisations and self-help groups that are involved in the reduction of fertiliser use and awareness generation.
- A state's increase or reduction in urea in a year will be compared to its average consumption of urea during the last three years.
- For this purpose, data available on a Fertiliser Ministry

dashboard, iFMS (Integrated Fertilisers Management **System**), will be used.

#### ✤ <u>Context</u> Decision of a Bench of Larger Strength will

Prevail

A Constitution Bench recently decided that majority decision of a Bench of larger strength will prevail over the decision of a Bench of lesser strength, irrespective of the number of judges constituting the majority.

#### Key Highlights

Under Article 145(5) of the Constitution, concurrence of a majority of the judges at the hearing would be considered as a judgment or opinion of the court.
